SWEEPSTAKES GRAND PRIZE WINNER NOTIFICATION: Potential Sweepstakes Grand Prize winners will be notified by email and will be required to complete and return via email/email link, an Affidavit of Eligibility/Declaration of Eligibility, a Release of Liability and, if legally permissible, a Publicity Release within three (3) days of Administrator's attempted delivery of same.
